



Tuition Assistance Policy

INTRODUCTION

Funds are set aside each year to assist those families unable to meet their tuition obligation. Under this program, a tuition assistance is available to families at Lititz Christian School with demonstrated financial need.

The FACTS Grant and Aid Assessment application is to be used when requesting assistance. The deadline for applying is April 1 unless your child was admitted after that date. We have a rolling deadline for new families. If difficulty is encountered in making tuition payments during the school year, this application should be submitted immediately. A determination will be made within 30 days and you will be notified of your award amount via email.

Lititz Christian School's Tuition Assistance Program is not funded with tuition dollars and is limited. Therefore, it is not guaranteed year to year. The amount of assistance we can award our families is based on donations to our Tuition Assistance fund. It is also determined by Earned Income Tax Credit (EITC) and Special Purpose Entity (SPE) funds that are graciously directed to Lititz Christian by local businesses and individuals. Amounts awarded typically range between 5% and 20% of the tuition, although a greater or lesser amount may be awarded based on availability of funds and/or other circumstances.

Tuition Assistance applications will only be considered if:

- Tuition accounts are current
- Enrollment fees are paid for the upcoming school year
- Online enrollment is fully completed

Tuition Assistance may be withdrawn if your tuition account is not paid on a current basis.

Recipients of financial assistance agree to inform Lititz Christian School's finance office immediately, and in writing, if any change in financial status affects the qualifications for the assistance. When tuition assistance is awarded for more than one family member, withdrawal of one or more students proportionately reduces the amount allocated to that family.

Lititz Christian School does not discriminate on the basis of race, color, nationality or ethnic origin in administering its tuition Assistance program.

EITC/ SPE GUIDELINES
For families who qualify based on financial need

The applicant’s household adjustable gross income may not exceed \$96,676 for the 2022-23 school year, plus an income allowance of \$17,017 for each eligible student and dependent member of the household, as defined by IRS guidelines. Household income does **not** include: disability payments, worker’s compensation, retirement pensions, public Assistance or unemployment compensation, reimbursement for work-related expenses, employer or union payments for hospitalization, death benefits, supplemental unemployment, strike benefits, social security and retirement, and combat pay for military personnel.

For each additional child or dependent (as defined by IRS guidelines), \$17,017 may be added.

- Assurances awarded through monies received through EITC will meet the family income guidelines established by the state of Pennsylvania for the Educational Improvement Tax Credit program.
- Assistance monies received through EITC will be used entirely for assurances to Pennsylvania families.
- Complete financial disclosure is necessary so that we can properly evaluate the request and offer recommendations. All applications will be secured in such a way as to protect the confidentiality of the information provided by the family.
- Any family withdrawing students that received assurances will be liable to return unused assistance monies. The number of days attended will be prorated to determine the amount of monies to be returned.
- Assurances awarded to families from EITC will not exceed 100% of tuition.
- Do not leave any questions blank. Incomplete applications will be returned. Every part of the application must be answered to the satisfaction of the school administrator and the school board.
- If parents are divorced or separated, or do not reside in the same household, the custodial parent must provide the information requested.
